A BILL FOR AN ACT

To appropriate the sum of \$23,230.55 from the Local Revenue Fund of the Kosrae State Treasury for fiscal year ending September 30, 2025 for the purpose of providing financial support to the parents of Xavier High School students for student tuition fees; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$23,230.55 is hereby appropriated from the Local  
2 Revenue Fund of the Kosrae State Treasury fiscal year ending September 30, 2025 for the  
3 purpose of providing financial support to the parents of Xavier High School students for student  
4 tuition fees.

5 Section 2. Apportionment. The amount shall be apportioned as follows:


6 (1) Xavier High School - Kosrae Students Tuition Fee \$23,230.55

7 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,  
8 managed, administered and accounted for in accordance with applicable laws. The allottee of  
9 the fund appropriated shall be the Governor of the State of Kosrae, who shall be responsible for  
10 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for  
11 which are appropriated and that no obligations are incurred in excess of the sum appropriated.

12 Section 4. Effective Date. This act shall become law upon approval by the Governor or  
13 upon its becoming law without such approval.
