A BILL FOR AN ACT

To amend the Kosrae State Code by amending Section 5.201 (1)(c) of Title 5, to restructure the Department of Finance & Administration by repealing the Office of the Overseas Development Assistance and placing the office under the Office of the Governor; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to amend the Kosrae State Code by
2 amending Section 5.201 (1)(c) of Title 5, to restructure the Department of Finance &
3 Administration by repealing the Office of the Overseas Development Assistance and
4 placing the office under the Office of the Governor.

5 Section 2. Amendment. Section 5.201 (1)(c), Chapter 2, Title 5 of the Kosrae
6 State Code is hereby amended to read as follows:


