A RESOLUTION

Consenting and confirming of Dr. Tulensru E. Waguk (Ph.D), to serve as the Director of the Department of Education.

1           **WHEREAS**, pursuant to Section 12 of Article V of the Kosrae State Constitution, each  
2 Principal Department of the government is under the supervision of the Governor and is headed  
3 by a director; and

4           **WHEREAS**, pursuant to Section 12 of Article V of the Kosrae State Constitution,  
5 directors are nominated and appointed by the Governor, with the advice and consent of the  
6 Legislature, to serve at the pleasure of the Governor during his term of office and until the  
7 appointment and qualification of their successors; and

8           **WHEREAS**, pursuant to Section 4.203 (1) of Title 4 of the Kosrae State Code, the  
9 Governor nominates a person to the directorship of a department within sixty days of taking  
10 office following election; and

11           **WHEREAS**, through Governor's Message 13-06, transmitted and received on March 01,  
12 2023, The Honorable Tulensa W. Palik has nominated Dr. Tulensru E. Waguk (Ph.D.), to be the  
13 Director of the Kosrae State Department of Education; and

14           **WHEREAS**, pursuant to Section 4.203(2) of Title 4 of the Kosrae State Code, within  
15 sixty days of the Legislature's receipt of a nomination the committee to which the Speaker  
16 assigns the nomination calls and concludes hearing on the nomination unless the Legislature by  
17 resolution allows a further period; and


1           **WHEREAS**, the Standing Committee on Education and Cultural Affairs has been
